Water Bills are always due March 31st, June 30th, September 30st, and December 31st.

Payment Options

❖ **Online banking:**

- Add Cherry Creek Waterworks as a payee.
 - For Quarterly Water Tolls use your account number **only** (ex.10101).
 - **For Parcel Tax, use your account number Plus a P on the end** (ex. 10101P).

❖ **Cheques** can be put into our mail slot at the office. Please do NOT put CASH in the mail slot.

❖ **Debit/Cheque/Cash** in office.

❖ **Pay at your bank.**

New Rates for the 2025 Parcel Tax and Water Tolls.



Metered Connections (Billed Quarterly)

Type of Connection	Base Rate	Included Cubic Meters	Overage Rate/Cubic Meter
Single Family	\$154	100	\$1.00
Multi Family	\$308	200	\$1.00
Farm	\$123	165	\$1.00

Parcel Tax (Billed Yearly)

- a) \$788.00 on all parcels of land classified as Single dwelling.
- b) \$1,052.00 on all parcels of land classified as Multiple dwelling.
- c) \$1,246.00 on all parcels of land classified as Trailer Park/ Motel/Hotel/Campground.
- d) \$777.00 on all parcels of land classified as Undeveloped Land.
- e) \$1,085.00 on all parcels of land classified as Commercial.
- f) \$903.00 on all parcels of land classified as Farm.
- g) \$0.00 on all parcels of land classified as unable to Service/Exempt (connection not readily available).
