Does your Water Taste Earthy or Musty?

Through regular water testing, we can assure you that the water is still very safe to drink and should improve as Lacey Lake levels increase. These issues will also be nullified in the event the new treatment plant is installed. In the meantime, the following items may help:

- 1. Flush out your hot water tank.
- 2. Run the Clean Cycle on your washing machine.
- 3. Install a Charcoal Filter on your main drinking water faucet.
