WATER RESTRICTIONS

Cherry Creek Waterworks District has implemented Stage 1 Water Restrictions to ensure a safe, sustainable, long-term water supply through the dry summer months. We will keep the residents informed as to any further water conservation measures as the season progresses.

Even numbered addresses can water/sprinkle on even numbered days and odd numbered addresses can water/sprinkle on odd-numbered days from 6 - 9 am and 6 - 9 pm.

Residents can continue with drip/micro irrigation and hand watering any day to a maximum of two hours, including vegetable gardens. Residents can use a hose with a spring-loaded nozzle or watering pail/bucket to wash vehicles and outdoor surfaces.

WATER TOLLS OVERAGE CHARGES

Due to environmental changes and to encourage water conservation, water toll overage charges will be increased as follows:

July 1, 2020 - Water Tolls \$123, Farm \$98. Overage .65 cents per cubic meter over the threshold of 100m3
October 1, 2020 - .80 cents per cubic meter over the threshold of 100m3

WATER METER BOXES

Thank you to all customers for keeping the water meter boxes clear of any items such as vegetation, hedges or rocks. The clearing is helpful for the meter readers, water operators and contractors.
